SECTION-I

Instruction to Bidders

A. General Information:

- The Principal-cum-Superintendent, Dr. Abhin Chandra Homoeopathic Medical College & Hospital, UNIT- III, Bhubaneswar requires the service of reputed, well established, financially sound and registered Service Providers to provide the services of Laboratory Assistant, Machine Man-cum-Production Assistant, Night Watchers and Sweeper in the Mini Pharmacy attached to office of the Principal-cum-Superintendent, Dr. Abhin Chandra Homoeopathic Medical College & Hospital, Bhubaneswar under the Director AYUSH-Cum-Mission Director, National AYUSH Mission (NAM), Odisha.
- 2. The period of contract for providing the aforesaid service will be **02** (**two**) year from the date of effectiveness of the contract. The contract may be extended for a further period, on mutual consent depending upon the performance of the Service Provider subject to the discretion of the authority.
- 3. The Least Cost Selection Method (LCSM) shall be adopted to select the man power service provider. However, the. Director, AYUSH, Odisha, Bhubaneswar reserves the right to reject the lowest bid on the ground of being unreasonable or not workable. In this regard the decision of the Director, AYUSH Cum-Mission Director, NAM, Odisha, Bhubaneswar is final.
- 4. The L1 bidder shall be selected on the basis of the total amount quoted by the bidder taken into account each manpower cost wage (remuneration) per month (30 days) to be given to the person with proportionate share of EPF (Govt. share) & ESI (Govt. share), and amount of service charge of the agency on above total amount (wages per 30 days+ EPF Govt. share +ESI Govt. share). .The wage/remuneration to be given to the staff however must not be less than the latest Minimum Wage as notified by the Govt. of Odisha according to their category they belongs.
- 5. In case, the lowest bidder (L-1) is disqualified after selection for any reason, then negotiations will be made with the second lowest (L-2) bidder for award of contract at L-1 price. However, the decision of the Director, AYUSH, Odisha shall be final during the overall selection process.
- 6. The Director, AYUSH, Odisha reserves the right to terminate the contract at any time after giving 30 days' notice to the Service Provider on ground of unsatisfactory performance / violation of statutory obligations or terms of the contract etc. on receipt of the complaint from the respective Head of Office under which the man power of the selected service provider will operate.
- 7. The numbers of Manpower to be provided by the Service Provider as given in the schedule of requirement may be increased or reduced depending on requirement and availability of fund etc. The Service Provider cannot claim as a matter of right to provide all the man power as given in the schedule of requirement.
- 8. The interested bidders may visit the location where the manpower will be engaged on any working day between the office hours to have a thorough knowledge of the work to be performed before preparation and submission of the bid.

B. Submission of Bid:

- a) The proposal complete in all respect as specified must be accompanied with a non-refundable amount of Rs.2,240/- (Rupees Two Thousand Two Hundred and Forty) only towards Bid Processing Fee in shape of D. D. in favor of Principal-cum-Superintendent, Dr. Abhin Chandra Homoeopathic Medical College & Hospital payable at Bhubaneswar.
- b) EMD of Rs.66,500/-(Rupees sixty six thousand five hundred) only in form of Demand Draft in favor of Principal-cum-Superintendent, Dr. Abhin Chandra Homoeopathic Medical College & Hospital, Bhubaneswar drawn in any scheduled commercial bank and payable at Bhubaneswar must be submitted along with the Technical Bid failing which the bid will be out rightly rejected. EMD of unsuccessful bidders will be returned without interest after the award of the contract.
- c) Bids without bid processing fee and EMD shall be rejected.
- **d)** The EMD shall be forfeited if the successful bidder fails to undertake the work or fails to comply with any of the terms and conditions of the bid.

- f) The Tender Inviting Authority will not be responsible for any postal delay. Bids reached after due date will be summarily rejected.
- **g)** The bid has been invited under two bid systems i.e. Technical Bid and Financial Bid. The bidders are advised to submit two separate envelopes.
- h) The Technical Bid should be submitted in a sealed cover with proper paging of documents with an index on front page of the Technical Bid and the following should be super-scribed on the envelope.

"Technical Bid for providing different man power services"

i) The seal of the bidder should be affixed on the bottom left hand corner of the envelope.

j) Similarly the Financial Bid should be submitted in a sealed cover and the following should be super-scribed in the envelope.

- **k)** The seal of the bidder should be affixed on the bottom left hand corner of the envelope.
- I) Both sealed envelopes (Technical Bid & Financial Bid) must be kept in a bigger third sealed envelope super-scribing as under:

- m) Name, detail address telephone, fax, mobile no. email address of the bidder must be written in the bottom left hand corner of the bigger envelop in capital letters. Bidders are requested to ensure this positively.
- n) Selected bidder will have to deposit a Performance Security @ 10% of the contract value in the form of Bank Guarantee from any scheduled Bank situated within Odisha in favour of Principal-cum-Superintendent, Dr. Abhin Chandra Homoeopathic Medical College & Hospital, Bhubaneswar as per the prescribed format provided in the tender document at Section IX to be valid for a period of three months beyond the contract period. (I.e. Performance Bank Guarantee must be valid from the date of effectiveness of the contract to a period of three months beyond the contract period) as its commitment to perform services under the contract.
- o) Failure to comply with the requirements shall constitute sufficient grounds for forfeiture of the Performance Bank Guarantee. The Performance Bank Guarantee shall be released immediately after three months of expiry of the contract provided that there is no breach of contract on the part of the qualified bidder.
- **p)** No interest shall be paid on the Performance Bank Guarantee. In case, the contract is further extended beyond the initial contract period, the Bank Guarantee will have to be accordingly renewed by the deployed service provider as per the existing terms and conditions of the tender.

Bidders are required to furnish the following documents along with the Technical Bid:

- g. Copies of IT return for the last three assessment years i.e. up to 2019-20(Up to Date)
- h. Copies of EPF & ESI Registration Certificate.
- i. Copy of valid license under PSARA Act, 2005 (in case of Security Service)
- j. Copy of the first page of the Bank Pass Book , transaction statement of last 6 (six) months of the Service provider.
- k. Copies of Audited Income/Expenditure statements along with Balance Sheet for the last 3 (three) years ending dated 31.03.2020 from a Chartered Accountant.
- I. Copies of work orders from the previous organizations for providing similar services during last 05 (Five) years up to the last date of submission of bid.
- m. Undertaking regarding non-blacklisting (on stamp paper) as per Format Form T2
- n. Undertaking regarding non-pending of any judicial proceedings (On bidder's letterhead) in Form-T3.
- o. Valid address proof of the Registered Office/Branch Office of the respective Service Provider, located within Odisha, with the copies of office Telephone/ Electric Bill.

Any deviation from the prescribed procedures / required information / formats/ conditions shall result in out-right rejection of the bid. Any conditional bid shall be out- rightly rejected.

All entries along with the pages in the bid document should be legible, filled-in clearly and signed by the authorized representative. If the space for furnishing information is insufficient, a separate sheet duly signed by the authorized signatory should be attached.

The technical Bid will be opened at Dr. ACHMCH, BBSR on dated 22th October 2020 at 11.30 a.m by a Technical Committee constituted Director of AYUSH, Odisha, Bhubaneswar. The authorized representatives of the bidder who wish may be present on the spot at that time. The date of opening of the financial bid of the technically qualified bidders shall be intimated to them by the Principal Dr. ACHMC&H, BBSR in due course of time and it will be opened in presence of the authorized representatives of the technically qualified bidder who wish to be present on the spot at that time. It is not mandatory on the part of the tenderer to be present in person or through authorized representative at the time of opening of the financial bid.

The bid shall be valid for a period of **90 days** from the date of opening of the bids and no request for any variation in quoted rates and/withdrawal of bids on any ground by the bidder shall be entertained. Validity of the bids can be extended on mutual consent of the Director of AYUSH, Odisha, Bhubaneswar.

To assist in the analysis, evaluation and computation of bids, the **Director AYUSH Odisha, Bhubaneswar** may ask the bidders individually for clarification of their bids. The request for the clarification and the response shall be in writing but no change in the price or substance of the bid offered shall be permitted.

The bidder having the lowest evaluated financial bid (L-1) would be considered for award of the contract subject to fulfillment of the terms and conditions. However the **Director AYUSH Cum-MD NAM ODISHA** is not bound to accept the lowest quoted rate on ground of being unreasonable or not workable.

The quoted rates shall not be less than the minimum wages fixed/ notified by the Government of Odisha from time to time and shall include all statutory obligations.

The service provider shall be liable for all kinds of dues payable in respect of manpower deployed / provided under the contract and the authority or Principal Dr. ACHMC&H, BBSR shall not be liable for any dues for availing the services of the personnel.

The Financial bid will be opened in respect of those qualified bidders who qualify in the Technical Bid.

The price comparative statement of the price bid of all successful qualified technical bid tenderers will be prepared and placed by the concerned Technical Committee before the **Director of AYUSH, Odisha, Bhubaneswar** for selection of the out sourcing agency through an appropriate committee.

Director of AYUSH reserves the right to reject any or all bids and terminate the tender process without assigning any reason thereof.

SECTION-II

SCOPE OF THE WORK

A. NIGHT WATCHER

- 1. PRINCIPAL CUM SUPERINTENDEDNT DR ABHIN CHANDRA HOMOEOPATHIC MEDICAL COLLEGE & HOSPITAL, UNIT-III, BHUBANESWAR invites sealed bids for the eligible bidders for providing the security service at MINI-PHARMACY ATTACHED TO DR ABHIN CHANDRA HOMOEOPATHIC MEDICAL COLLEGE & HOSPITAL, UNIT-III, BHUBANEWAR.
- 2. The manpower for the security service shall be as required by the pharmacy-in-charge. However, the deployment of the security personnel may be varied with respect to the scope of the service, which can be increased/ decreased as per the convenience of the Principal Dr. ACHMC&H, BBSR.
- 3. The service Provider shall ensure that the security deputed are as per the scope of the work physically and mentally healthy and not more than 41 years of age or less than 18 years of age.
- 4. The full particulars of the personnel to be deployed by the service provider including their names and addresses shall be furnished along with testimonials before they are actually deployed for the job.
- <u>5.</u> Visitors shall be regulated as per the direction of the Principal Dr. ACHMC&H, BBSR and procedure and records thereof shall be maintained as stipulated therein.
- 6. A senior level representative of the Service provider shall visit the Office premises as leaser once a week and review the service performance of its personnel. During the weekly visit. Service provider's representative will also meet the representative of the Authority dealing with service under the contract for mutual feedback regarding the work performed and removal of deficiencies. If any, observed in their working.
- <u>7.</u> The incidental expenses towards shoes, shocks, caps torch stick, umbrella and raincoat etc., shall be borne/supplied by the service provider at its own cost.
- 8. The day-to-day functioning of the services shall be carried out in consultation with and under direction of the Principal Dr. ACHMC&H, BBSR. Proposals for efficient functioning of the security systems shall be discussed considered and implemented from time to time by the service provider with the approval of the tender inviting authority.
- 9. Any loss caused to the tender inviting authority due to the lapse on the part of the security personnel discharging responsibility, will be borne by the service provider and in this connection, the tender inviting authority shall have the right to deduct appropriate amount form the bill of the service provider to make good such loss besides imposition of penalty. In case of frequent lapses on part of the security personnel deployed by the service provider, Authority shall be within its right to terminate the contract or take any other action without assigning any reason whatsoever.
- 10. The service provider shall ensure that any replacement of the personnel as required by the tender inviting authority for any reason specified or otherwise, shall be effected promptly without any additional cost to the tender inviting authority. If the service provider wishes to replace any of the personnel, the same shall be done with prior intimation to the tender inviting authority at the service providers cost.

B - SWEEPER AND CLEANING

 Cleaning, sweeping, mopping, dusting and wiping of floors, staircases, rooms, furniture with appropriate cleaning agent, on daily basis or more frequently as will be required by the concerned Officer-in-Charge. Cleaning activity shall start in the

- morning at 7.00 A.M so as to complete all the dusting/cleaning/mopping work before 09.00A.M
- Thorough cleaning of all toilets, wash basins at least thrice daily (at 8.00 AM, 12.00 Noon and 3.30 P.M) with phenyl and detergent etc. and maintain the toilet floors dry during office hours
- Cleaning of windows and window slits of all toilets to be done regularly. Wash basins, urinals are to be cleaned with suitable detergents. Flushing system of all toilets is to be checked at regular interval every day.
- A duty chart must be maintained by the Service Provider which shall contain the regular attendance of the personnel engaged in cleaning works.
- Collection of waste paper from rooms, waste paper baskets, lobbies and putting in bags at the specified location daily at 9A.M.
- Cleaning of blockage in sewer and pumping lines, drainage and manholes within the office premises as and when required.
- Cleaning gulley trap and manholes within and surrounding of premises as and when enquired.
- Cleaning/removal of any type of stains of ink etc. from the building premises and stair cases.
- Lifting, carrying and disposing the dead birds, animals, rats, and insects' etc. if found in and around the office building.
- Removal of beehives and cobwebs/honey webs from the office building and its premises and cleaning and sweeping of open area include balconies and rooftops.
- The Service provider should possess or procure required safety gadgets and other material for smooth services.

C - MACHINE MAN- CUM - PROUCTION ASSISTANT

Responsibilities

- To run the machines
- Set up machines (calibration, cleaning etc.) to start a production cycle
- Control and adjust machine settings (e.g. Speed)
- Feed raw material or parts to semi-automated machines
- Inspect parts with precision and measuring tools
- Test operation of machines periodically
- Fix issues that might occur during the operation of the machines
- Check output to spot any machine-related mistakes or flaws
- Keep records of approved and defective units or final products.
- Maintain activity logs
- Any other duty to be assigned by the officer-in-charge of the Pharmacies or tender

inviting authority.

D - LABORATORY ASSISTANT

- Assisting in-house testing, Collection, preparing and /or testing samples conducting and supporting scientific investigations and experiments.
- Providing technical support to the Govt. Analyst.
- Writing or assist in writing reports, summaries etc.
- Recording and analyzing data.
- Planning, setting up and undertaking controlled experiments and trials.
- Demonstrating procedures.
- Maintaining, calibrating, cleaning and testing sterility of the equipment
- Presenting results to senior staff.
- Ordering and maintaining stock and resources.
- Any other responsibility assigned by the Pharmacy-in-Charge or tender inviting authority

SECTION - IV

GENERAL TERMS AND CONDITIONS

- 1. For all intents and purposes, the Service Provider shall be the "Employer" within the meaning of different Rules & Acts in respect of persons deployed. The persons deployed by the service provider shall not have any claim whatsoever like employer and employee relationship against the Authority under this agreement. The Service Provider shall make them known about their position in writing before deployment under the required service.
- 2. The Service Provider must employ adult labor only. Employment of child labor will lead to the termination of the contract. Persons to be deployed by the Service Provider should be above 18 years of age and not exceeding 41 years and physically sound to perform the duties.
- 3. The Service Provider will be overall responsible for the manpower deployed for performing the service. The Authority or tender inviting authority shall not be responsible for any financial loss or any injury to any person deployed by the Service Provider in the course of their performing the functions/ duties, or for payment towards any compensation.
- The Service Provider shall exercise adequate supervision to ensure performance of manpower deployed to provide the services in accordance with the requirements. The Service Provider shall depute one full time supervisor in concerned office of the authority, for overall management of the services to be rendered at the site with permission of the tender inviting authority if it is desired so.
- 5. The Service provider shall be solely responsible for compliance to the provisions of various Labor and industrial laws, such as, wages, allowances, compensation, EPF & ESI, Bonus and Gratuity etc. relating to manpower to be deployed by it at the tender inviting Authority's location.
- 6 Service Provider shall maintain complete official records of disbursement of wages/ salary showing details of all supporting documents such as ESI, EPF etc. in respect of manpower deployed for the purpose.
- 7. The Service Provider shall maintain personal file in respect of all the staff who are deployed in office of the tender inviting authority. The personal file shall invariably consist of personal details such as name, address, date of birth, sex, residential address (temporary/permanent), Bank Account, EPF/ESIC Detailed.
- The manpower to be deployed by the Service Provider should not have any adverse

Police records/criminal cases against them. The agency should make adequate enquiries about the character and antecedents of the persons whom they are recommending. The manpower service provider prior to signing of the agreement must provide an undertaking to this respect.

- 9. The Service Provider will also ensure that the manpower deployed are medically fit and will keep in record a certificate of their medical fitness. The Service Provider shall withdraw such manpower that is not found suitable by the tender inviting authority/ **Director of AYUSH, Odisha, Bhubaneswar** for any reasons immediately on receipt of such a request.
- 10. The Service provider shall ensure that the manpower deployed by it are disciplined and do not participate in any activity detrimental to the interest of the tender inviting authority.
- 11. The Service Provider shall provide uniform along with Photo ID Card to its personnel deployed at site at its own cost.
- The tender inviting Authority/ **DIRECTOR OF AYUSH**, **Odisha**, **Bhubaneswar** shall not be liable for any compensation whatever the reason may be or in case of any fatal injury/death caused to any man power while performing/discharging their duties/ for inspection or otherwise.
- In case of any theft or pilferages, loss or other offences, the service provider will investigate and submit the report to the Tender Inviting Authority and maintain liaison with the police. FIR will be lodged by the concerned tender inviting authority, wherever necessary. If need be, joint enquiry comprising of both the parties shall be conducted and responsibility will be fixed.
- In case of any loss caused to the Tender Inviting Authority due to lapse on the part of the personnel discharging duties, the same shall be borne by the Service Provider. The Tender Inviting Authority shall have the right to deduct appropriate amount from the bill of service provider. In case of frequent lapses on the part of the personnel deployed by the service provider, Tender Inviting Authority on approval of the Director AYUSH shall terminate the contract or take any other action without assigning any reason whatsoever.
- In the event of any personnel being on leave/absent, the service provider shall ensure suitable alternative arrangements to make up for such absence. If a person leaves the job for any reason, the Service provider is liable to provide the suitable replacement within 3 working days.
- In case of delay in providing required replacement, the amount of penalty calculated at the rate of 1% of the annual contract value per week on account of delay, shall be deducted from the monthly bills in the succeeding month.

- 17. There would be no increase in rates payable to the Service Provider during the Contract period. The service provider will be responsible for deposit of EPF, ESI, GST and other statutory dues as applicable from time to time and submit the proof of deposit to tender inviting authority for records before payment of the subsequent dues.
- The Service Provider shall not be allowed to transfer, assign, pledge or subcontract its rights and liabilities under this Agreement to any other agency or organization. Subcontracting is not allowed under this agreement.
- 19. The Services Provider shall raise the bill, in **triplicate**, along with attendance sheet duly verified by the officer concerned in respect of the persons deployed and submit the same to the Principal Dr. ACHMC&H, BBSR, in the first week of the succeeding month. The payment will be released by the second week of the succeeding month. The percentage of GST/IT as applicable and instructed by State Govt. will be deducted from the payment as TDS.
- 20. The Service Provider will have to deposit the remuneration of the deployed manpower for the concerned billing period in their respective bank account through online transfer and submit the details to the Principal-cum-Superintendent, Dr. A. C. Homoeopathic Medical College and Hospital, Bhubaneswar for necessary records.
- 21.
