Terms and Conditions for acceptance of tender for supply of Glass bottles(100ml), Ropp Cap, Self-sealing caps, Inner dropping corks, Paper cartons, Multi coloured self-adhesive labels, Crude drugs & Back Potency, 200 litre capacity of HDPE drums to the Homoeopathic Mini Pharmacy of Dr. Abhin Chandra Homoeopathic Medical College & Hospital, Bhubaneswar during the year 2020-21.

Sealed tenders should reach the office of the Principal-cum-Superintendent, Dr. Abhin Chandra Homoeopathic Medical College and Hospital, Unit – III, Kharvela Nagar, Bhubaneswar – 751 001 by 5P.M on 29th December 2020. Tender received beyond the scheduled date and time will not be entertained.

The tender has been invited under Two Bid system i.e. Technical Bid and Financial Bid. The interested firms are advised to submit tender papers in two separate sealed envelopes super scribing "Technical bid for supply of 100 ml Glass bottles, Ropp Cap, Self-sealing caps, Inner dropping corks, Paper cartons, Multi coloured self-adhesive labels, Crude drugs & Back Potency, 200 litre capacity of HDPE drums" and "Price bid for supply of 100 ml Glass bottles, Ropp Cap, Self-sealing caps, Inner dropping corks, Paper cartons, Multi coloured self-adhesive labels, Crude drugs & Back Potency, 200 litre capacity of HDPE drums". Both sealed envelopes should be kept in a third sealed envelope super scribing "Tender for supply of 100 ml Glass bottles, Ropp Cap, Self-sealing caps, Inner dropping corks, Paper cartons, Multi coloured self-adhesive labels, Crude drugs & Back Potency, 200 litre capacity of HDPE drums for the year 2020-21".

- 2. Technical bid will be opened by the Director, AYUSH, Odisha, Bhubaneswar or his authorized officer before a Technical committee constituted for the same purpose, at **11.30 A. M on 30th December 2020** in the office chamber of the Mini Pharmacy of Dr. Abhin Chandra Homoeopathic Medical College and Hospital, Bhubaneswar. The bidder or his authorized person / representative may remain present at the time of opening of tenders, if they so desire. The Technical committee will examine the documents and the allied matters as per terms & conditions stipulated in the tender and will segregate the submitted tenders in two groups' i.e. eligible & non-eligible categories.
- 3. The schedule of opening of price bid of eligible bidders qualified in technical bid will be intimated by the authority after verification of bid documents.
- 4. In the event of the last date for submission of tender being declared as a holiday by the Govt., the due date of submission and opening of tender will be the next working day following the scheduled day for submission and opening of tender.
- 5. Tender should be computer generated written and every correction in the tender should be duly attested by the bidder.

4. EARNEST MONEY DEPOSIT

- 4.1 The bidder shall have to deposit a sum of ₹62500/ (sixty two thousand five hundred only) as Earnest Money Deposit (EMD) in shape of A/C payee Demand Draft in favour of Principal-cum-Superintendent, Dr. Abhin Chandra Homoeopathic Medical College and Hospital, Bhubaneswar to be drawn from any Nationalized Bank payable at Bhubaneswar or Fixed deposit receipt/ Bankers cheque/Bank guarantee from any of the commercial Banks in an acceptable form. The model bank guarantee format for furnishing EMD is available at Appendix-This should be sent along with the tender. E.M.D. in any other form other than above will not be accepted.
- 4.2 The EMD is to be normally valid for a period of 45 days beyond the bid validity period. The bidders who are exempted from paying EMD shall have to produce relevant orders from the competent authority. EMD of the unsuccessful bidders will be remitted back after finalization of the tender. The E.M.D. of the successful bidders will be returned back only after receiving the Performance Security deposit.

5.TENDER CONDITIONS; -

The tender should be accompanied with the following as per the check list:

- 5.1 Check list duly filled by the bidder.
- 5.2 Covering letter of Technical bid as per annexure -10 duly filled by the bidder
- 5.3 Covering letter of Financial bid as per annexure -11 duly filled by the bidder
- 5.4 A self-attested copy of GST registration certificate.
- 5.5 A self-attested copy of up-to-date GST Clearance Certificate.
- 5.6 Earnest Money Deposit as mentioned.
- 5.7 The tender documents and the schedules in original duly signed by the bidder at the bottom of each page with office seal and the original receipt in support of purchase of tender paper.
- 5.8 A declaration form for abiding the terms and conditions as per the proforma enclosed at **Annexure I**.
- 5.9 A self-attested copy of PAN card of the bidder.
- 5.10 Original money receipt towards the purchase of tender paper or a Bank Draft amounting to Rs 525/- in favour of the Principal-cum-Superintendent, Dr.
 A. C. Homoeopathic Medical College and Hospital, Bhubaneswar, drawn from any nationalized / scheduled bank payable at Bhubaneswar by those who have downloaded the tender paper from website.
- 5.11 The rates quoted by outside state firms should include G.S.T, other taxes if any and all other expenditure till delivery of items at F.O.R. destination. Inside state firms should quote their rate adding GST, all other taxes and expenditure till delivery of goods at the F.O.R. destination. The detail specification of items to be procured during this tendering process is enclosed at **Annexure -2** and specification of crude drugs is enclosed in **Annexure-3**. The GST rate should be indicated separately in the schedule against each item as per model tender format (price schedule) at **Annexure-4**. The list of Back Potencies and crude drugs to be procured are enclosed at **Annexure -5**, **6**, **7** and **8** respectively.

- 5.12 The samples of all the quoted items such as 100 ml glass bottles, Ropp Caps, self-sealing caps, inner dropping corks, Crude drugs, Paper cartons, Multi coloured self-adhesive labels & Back Potencies should be submitted by the firms putting their signature with their firm name at the time of submission of tender paper for verification/testing by the appropriate Committee free of cost. However, the bidder shall submit 250 gms of each crude drug item, two 100 ml phials of back potencies one each for 28th 29th & 199th from the list and two 100 ml glass bottles, 10 Ropp Caps, 10 self-sealing caps, 10 inner dropping corks, one Paper carton with its complete partition, samples self-adhesive labels and one 200 litre capacity of HDPE drums as per specification
- **5.13** The firms participating in tender process for the supply of Back Potencies must submit the self-attested copy of the valid Manufacturing license issued in favour of him or the authorisation certificate from a firm having valid manufacturing license.

6. SECURITY DEPOSIT / PERFORMANCE SECURITY

- 6.1 The successful bidders who are awarded with purchase order are required to deposit 10% of the total ordered value in shape of A/C payee Bank Draft duly pledged in favour of the Principal-cum-Superintendent, Dr. A. C. Homoeopathic Medical College and Hospital, Bhubaneswar from any nationalized / scheduled bank payable at Bhubaneswar or Fixed deposit receipt/ Bankers cheque/Bank guarantee from any Commercial Bank in an acceptable form (The model bank guarantee format for furnishing EMD is available at **Appendix-2**) as Security Deposit within 10 days from the date of issue of the supply order.
- 6.2 The security money deposit will be returned to the bidder only after successful compliance of the supply orders.
- 6.3 Failure to deposit the Security Deposit / Performance Security will call for cancellation of the order and the further claim for supply by the bidder will not be entertained.

7. GENERAL CONDITIONS

- 7.1 The terms, conditions and the quoted price once approved shall remain valid for a period of 12 months from the date of approval of the tender or up to the date of publication of next tender whichever is earlier.
- 7.2 The rates approved by the Purchase Committee shall be binding on the bidder for a period of one year from the date of approval of tender and on no account request for increase of rates at any point of time till expiry will be entertained.
- 7.3 The items shall be selected on the basis of quality on competitive price basis and as such acceptance of lowest quotation is not obligatory.

- 7.4 The bidders are required to supply their articles in full quantities in good condition as mentioned at Annexure-III at their own cost within a period of 30 days from the date of issue of the supply order. If supply will not be completed within 30 days of issue of supply order, a maximum period of another 30 days may be allowed for extension on written request with penalty money of 0.5% of the total purchase order value per week or part thereof for delayed supplies as liquidated damage up to maximum 5% on purchase order value and which will be deducted from his payment. If supply will not be completed within the period of liquidated damage, the purchase order for the un-supplied item will be cancelled and no further purchase order will be placed to the firm for said item and the firm will be blacklisted for the said item only for two years.
- 7.5 If any item of supplied articles is found defective in comparison to the approved sample by the technical committee, like broken or damaged during receipt of supply at destination, the same will not be accepted and to be taken back in full quantity by the supplier and have to resupply again within due time. The cost of short supply / defective / damaged items will be deducted from the total bill amount.
- 7.6 If any information or documents furnished by the bidder in the tender paper are found to be misleading or in-correct at any stage, the tender of the relevant items in the approved list shall be cancelled and the concerned firm shall be black listed for supply for next 2 years for the products and his security deposit will be forfeited.
- 7.7 Director AYUSH, Bhubaneswar reserves the right to reject the tenders or to accept the tenders for supply of all articles or any part of the articles tendered for without assigning any reason thereof.
- 7.8 The bidder should not be permitted to alter or modify their bids after expiry of the deadline for receipt of bids.
- 7.9 No item will be received by the store without submission of Challan against the supplied item.

8. TERMS OF PAYMENT

- 8.1 The bills will be drawn in favour of the firm concerned and the payments will be made only after submission of necessary challan with stock entry certificate in triplicate from the officer to whom the supply would be made and invoices in triplicate in the name of Principal-cum-Superintendent, Dr. Abhin Chandra Homoeopathic Medical College and Hospital, Bhubaneswar.
- 8.2 If the bidder fails to execute the supply within the stipulated time, the Principal-cum-Superintendent, Dr. Abhin Chandra Homoeopathic Medical College and Hospital, Bhubaneswar will be free to make emergency purchases from the firm / firms quoting prices in ascending order and claim the difference from the defaulting firms under intimation to the Director AYUSH, Bhubaneswar. On failure to compensate the differential amount, the same shall be deducted from the security deposit of the defaulting firm.
- 8.3 No advance payment will be made to the bidder towards the cost of the articles.
- 8.4 The payment shall be made to the supplier through E. Banking.
- 8.5 Payment of the supplied goods only be released, if it passes all the quality norms examined by a technical committee constituted for same purpose, if they fail then the concerned firm must replace the items in full quantity at his own cost up to F.O.R. destination within fifteen days from the date of rejection by the technical committee.
- 8.6 In the event of any litigation arising out of supply of articles, such matter would be subject to the jurisdiction of civil court, Bhubaneswar or High court of Odisha.

9. **AGREEMENT**:

The successful bidders will have to furnish agreements with their signatures in non judicial stamp papers of Rs 10.00 to the Principal-cum-Superintendent, Dr Abhin Chandra Homoeopathic Medical College & Hospital Bhubaneswar before executing supplies to the respective pharmacies .A specimen copy of agreement form is attached to the Tender Book at Appendix-3

10. ARBITRATION CLAUSE:

In case of any dispute between the purchaser and the supplier arising under the contract or regarding interpretation of the terms & conditions of the contract, the decision of the Principal-cum-Superintendent, Dr Abhin Chandra Homoeopathic Medical College & Hospital Bhubaneswar shall be final & binding for both the parties. In case of any legal dispute arises out of above contract or tender, the dispute will be settled within the Jurisdiction of Hon'ble Court of Odisha, Cuttack
